Parkland Alienation and Conversion

Municipally owned parkland and open space are nonrenewable resources which are carefully preserved in all communities. While the preservation of municipal parks and open space is our goal, OPRHP recognizes that sometimes a change in use of parkland may be necessary. OPRHP endorses a "no net loss of parkland" policy.

Parkland "alienation" occurs when a municipality wishes to sell, lease, or discontinue municipal parkland. These actions require the municipality to receive prior authorization from the State in the form of legislation enacted by the New York State Legislature and approved by the Governor. Parkland "conversion" may also apply to municipal parks in New York State. Parks with Federal dollars invested are subject to both alienation and conversion procedures.

ALIENATION:

Occurs when a municipality sells, leases or discontinues parkland.

The primary role of OPRHP is to provide advice and guidance to the municipality, concerned citizens, the Governor and the Legislature. In instances where public grant funds have been invested in the park, OPRHP is more involved.

When considering a change in use of parkland or recreational areas, the municipality must:

- First determine if the action is an alienation.
- 2. Explore other options to avoid using parkland.
- 3. Involve the public.
- 4. Notify OPRHP—municipalities are encouraged to contact the Regional Grants Officer in their area early in the process.
- 5. Determine if State or Federal funds were invested in the park.
- 6. Complete the Parkland Alienation Municipal Information Form (see *Handbook*)
- 7. Contact your local State legislative sponsor.
- 8. Draft legislation with the help of the legislative sponsor and OPRHP Counsels Office
- 9. Pass a Municipal Home Rule Request.
- 10. Conduct a review pursuant to State Environmental Quality Review Act (SEQR)

CONVERSION:

Only applies to municipal parks that have received Federal Land and Water Conservation Fund (LWCF) or Urban Park and Recreation Recovery Program (UPARR) funds and are being conveyed or taken out of outdoor recreation use, in whole or in part.

The role of OPRHP is to act as a liaison between the municipality and the National Park Service (NPS).

When a municipality is considering the conversion of Federally mapped parkland (resulting from a LWCF or UPARR grant) it must work through OPRHP to seek NPS approval, as follows:

- Complete an environmental review with documentation pursuant to the National Environmental Policy Act (NEPA).
- 2. Determine the effect of the conversion on historic resources pursuant to NEPA.
- 3. Select substitute lands and submit appraisals (Federal standards apply).
- 4. Ensure that replacement lands and remaining lands meet eligibility requirements.
- 5. Coordinate review with other Federal Agencies.
- 6. Prepare survey maps.
- 7. Submit the package to the NPS through OPRHP.

NOTE: Generally speaking, conversion of municipal parkland is also alienation. Alienation legislation must be enacted prior to submission of the conversion package to NPS.
